CHCM Hosts Joint Advisory Board Tour

This summer, the Community Health Commission of Missouri (CHCM) hit the road for a three-stop advisory board tour across Kansas City, St. Louis, and the Bootheel. At each gathering, our implementation team convened members from across all of our advisory boards—including community members navigating our healthcare and social systems, providers, social service partners, and safety net and public health officials. These in-person meetings created an important space to share updates, collect feedback on our upcoming strategic plan, and listen closely to what communities need most as we look ahead.

From the momentum in Kansas City, to the strong local voices in St. Louis, to the deep-rooted perspectives in the Bootheel, every stop added vital insight to CHCM's statewide work. These conversations will help shape our new strategic plan (launching soon!) and ensure that equity-centered, community-driven solutions remain at the heart of what we do.

AIR of Equity Initiative



CHCM launches "AIR of Equity" Program

CHCM is excited to announce that applications are now open for the <u>AIR of Equity Artist-in-Residence Program</u>. In partnership with the <u>Regional Arts Commission of St. Louis</u>, this year-long residency merges artistic innovation with health equity advocacy, offering an immersive opportunity for one St. Louis-based artist to create alongside communities most affected by health disparities.

The selected artist will spend 12 months embedded within CHCM, collaborating with community partners and residents to co-create projects that uplift lived experiences and spark conversations around racial and economic health inequities.

Residency highlights and creative aims:



A stipend available, up to \$10,000



\$5,000 project and materials budget



Hosting at least one community engagement event, such as storytelling circles, workshops, or installations



Co-creating works informed by community voices and CHCM's health equity data



A final public showcase in June 2026

Protecting Medicaid

Our Advocacy & Storytelling Initiatives



HR1 Passage Response

In response to the passage of HR1—otherwise known as "The Big Beautiful Bill"—CHCM reaffirmed its steadfast commitment to Missouri's most impacted communities. As CEO Riisa Rawlins emphasized, "When systems fall short, people rise-up—with creativity, compassion, and collaboration."

Shortly after, CHCM joined partners statewide to amplify this concern, warning that the bill "imposes funding cuts and administrative barriers on programs that support children and families, jeopardizing their access to basic needs like healthcare and food."

Medicaid Storytelling

As lawmakers advance HR1, CHCM is amplifying the lived experiences of Missourians who stand to lose coverage and care as a result of proposed cuts. These stories remind us that behind every policy debate are real people navigating coverage gaps, rural hospital closures, and other barriers to essential care.

Thanks to support from our national advocacy partner, <u>Families USA</u>, we've been able to expand storytelling across the state. With storytellers from St. Louis, Kansas City, and the Bootheel, we're uplifting diverse voices that show how policy decisions ripple through communities—whether it's parents working to keep kids healthy, seniors managing chronic conditions, or families facing the loss of nearby hospitals.



Protecting Medicaid

CHCM Co-hosts "Medicaid at Risk Part II" panel discussion in partnership with the Brown School at Washington University in St. Louis

Nonprofit Advocacy

On August 14–15, the <u>Black Community Fund (BCF)</u> hosted its Vision Workshop 2.0 at the Kauffman Conference Center in Kansas City, bringing together nonprofit leaders and community advocates for two days of learning and connection. Among the sessions offered was "Realizing Your Power: The Basics of Nonprofit Policy Advocacy and Systems Change," facilitated by CHCM Policy and Advocacy Director Robert Gibson and Nate Madden of the Health Forward Foundation.

In their session, participants explored the key differences between advocacy and lobbying, gaining clarity on how nonprofits can engage in both direct and grassroots lobbying while staying compliant and effective.





Missouri Policy

CHCM Submits testimony in opposition to initiative petition restrictions and partisan redistricting

On September 4, 2025, the Community Health Commission of Missouri (CHCM) <u>submitted</u> <u>formal testimony</u> to the Missouri House in opposition to two proposals that threaten democracy and fair representation.

HJR 3 - "Protect Missouri Voters" Amendment

Would impose new barriers to the citizen initiative petition process, limiting Missourians' ability to directly shape policy. Amendments would require both a statewide majority and majority approval in all 8 congressional districts—making it significantly harder for voters to pass reforms.

HB 1 – Redistricting Provisions

Would reopen congressional redistricting before the next census, destabilizing representation and splitting Kansas City's 5th District—making it possible for Republicans to control 7 of 8 seats in the U.S. House.

CHCM stands firmly against these efforts to weaken civic participation and representation. We believe Missouri's democratic processes should remain open, fair, and accessible to the people they're meant to serve. Read our testimony in opposition for <u>HJR3 here</u> and <u>HB1 here</u>.

Rural Health Transformation Program

The Missouri Department of Social Services (DSS), through its MO HealthNet Division, is seeking public comment on the new <u>Rural Health Transformation Program</u>, a major federal initiative created under HR1, otherwise known as the One Big Beautiful Bill Act. The program will distribute \$50 billion nationwide between 2026 and 2030 to strengthen and innovate rural health care.

As Missouri prepares its application, community input will be critical. Each state must select at least three of nine eligible funding categories, and priorities identified during this public comment period will directly guide Missouri's request.

Partnership Spotlights



REACH Healthcare Foundation

Over the past several months, the Community Health Commission of Missouri (CHCM) partnered with the <u>REACH Healthcare Foundation</u> to host a series of Diversity, Equity, Inclusion, Accessibility, and Belonging (DEIAB) capacity-building workshops.

These five sessions, held between April and August 2025, brought together more than 100 nonprofit and community leaders to explore practical strategies for sustaining equity-centered, trauma-informed work in today's challenging environment.

Participants engaged in sessions on resilience and well-being for advocates, navigating policy changes, inclusive community leadership, and using data to drive systems change. Feedback showed strong outcomes: 100% of participants reported learning new strategies to sustain DEIAB efforts, and nearly all left feeling more confident in their ability to foster community engagement and equitable representation.

Most importantly, the workshops underscored the value of connection. Attendees emphasized that "fellowship matters" and that the opportunity to share experiences and strategies reminded them they are not alone in this work. Click here to read more or download the full report.











Partnership Spotlights



East Side Aligned

The East St. Louis Youth Institute, hosted by East Side Aligned in partnership with CHCM, brought together young leaders for a week of healing, connection, and empowerment. Through interactive workshops, youth explored the impact of trauma, practiced new coping tools, and discovered the power of using their voices for change.

Healing circles and peer learning were named as some of the most powerful parts of the Institute, creating space for reflection, connection, and resilience. Youth left not only with knowledge about trauma in their communities, but with a renewed sense of pride and responsibility.

Racial Equity Summit

CHCM at the 2025 Racial Equity Summit

This year's Racial Equity Summit, hosted by our partners at <u>Forward Through Ferguson</u>, was full of powerful conversations and community-led visioning. CHCM was proud to have several leaders take the stage to highlight critical issues at the intersection of equity, health, and justice.



Our CEO, Riisa Rawlins, moderated a compelling panel on birth equity, exploring how systems can better center Black mothers and families. On another stage, <u>Aja Owens</u> and <u>Kayla Thompson</u>—two St. Louis creatives and CHCM team members—shared their perspectives on the role of arts in advancing justice.

CHCM also hosted a session spotlighting our youth programming, where young leaders from our <u>Youth Ambassadors program</u> and participants in a week-long youth institute with <u>East Side Aligned</u> (see previous page) spoke about their experiences and hopes for the future.

We're grateful to <u>Forward Through Ferguson</u> for creating this space and to our staff, partners, and youth for bringing their voices forward.

In her role at CHCM, Courtney will take the helm of our Community Institutional Review Board (Community IRB) work. This initiative is reimagining research oversight by redistributing power, valuing lived experience, and ensuring research is not just about communities but led by them. The Community IRB will bring together voices from historically marginalized communities across Missouri to review and shape research through an equity-centered, trauma-informed lens.
